Temporary Fire Station Schedule, Bid Results, & Project Award

### **Background Info**

A Notice Inviting Sealed Bids for the Temporary Fire Station Project was posted on 05/27/2022. The Description of Work stated, "Work includes but is not limited to installation of utilities, connecting utilities to modular building and carport, fencing, electrical power and lighting including lighting inside the carport, generator ATS, connections, asphalt paving, coordination and assisting with installation of modular building, carport, generator, storage sheds and gate etc. District will be procuring the modular building, carport, generator, storage shed and the gates directly. All other electrical scope shown in the bid documents except the generator are in the bidder's scope."

Bids were opened on 06/20/2022 and verified for completeness to identify the apparent low bidder, OBS Engineering Inc. The second lowest bidder, ERA Construction, Inc. contested the low bidder's documentation and the matter was referred to the district's counsel, Meyers Nave. The apparent low bidder responded to the contest and Meyers Nave concurred that the protest has no merit and should be rejected. Counsel stated that the district may award the project to OBS Engineering Inc. Mack5's analysis of the bids is attached. Please note that allowances listed in the Notice To Bid totaling \$65,000 were added to each base bid amount, and are itemized in the spreadsheet. The total of the OBS Engineering Inc. bid is \$439,500.00.

Mack5 has update the project ROM estimate, which is also attached. The total is \$737,160. This does not include the soft costs, such as architecture, engineering, permitting, etc, (previously budgeted to be \$130K) nor the UUCB lease expense, which are tracked separately. The ROM estimate, though, is substantially lower than the 2020 construction estimate of \$900K with a total project estimate of \$1.5M. The revised total project estimate is \$835K plus the site lease, which is pending approval at a rate of \$1,300/month.

Mack5 has also updated the project schedule, which shows occupancy by the first week of October. Please see the related PSB renovation schedule in agenda item 3a, which explains why the temporary station work must be expedited due to the financing loan interest rate.


On June 15, 2022, the El Cerrito Planning Commission voted unanimously to approve the conditional use permit for the fire station at the UUCB parking lot. We have been notified, though, that a resident has filed an appeal and that the El Cerrito City Council will consider the matter on July 19<sup>th</sup>, 2022. We believe the appeal is without merit and will be denied.

Unfortunately, the appeal delays our building permit and leaves the district with no contingency time on the project schedule. As explained in the materials for agenda item 3a, further delays will jeopardize the financial feasibility of the seismic renovation work itself. Apparently, the appellant argues that the response time from the UUCB lot is not acceptable and requests that the district locate the temporary station at the Arlington Ave parking lot adjacent to the Kensington Library. In prior board meetings, the Fire Chief has explained that the response time from the UUCB lot is acceptable and that there are two directions the engines can respond to from the lot. In a prior remodel, the district responded to calls from a temporary location further away at the Arlington Park Clubhouse. The Chief has also explained that the Arlington Ave lot has access issues with the number of pedestrian users for the library, community center, park, and church, and that the steeper angle of the lot is not acceptable for parking the engines on a regular basis. The General Manager has added that the restricted width of the lot will not accommodate the modular building and the carport structure for the engines, as it will at the UUCB location, and that the utility connections would be more difficult.

Most importantly, the Arlington lot is split under two separate ownerships, the Arlington Community Church and the KPPCSD. The KPPCSD is considering the lot for the location of the police station and has not expressed any interest in leasing the site to the KFPD. Even if it were acceptable to both property owners, the design, engineering, and planning approval for the UUCB site has taken 9 months and repeating the process for the Arlington lot would substantially increase the costs for both the temporary fire station and the PSB seismic renovation, which would jeopardize the district's ability to proceed at all.

#### **Recommended Action**

Staff recommends approving the project schedule and authorizing the General Manager to contract for the work with the lowest qualified bidder.
